2. **Prerequisites:** Prior or concurrent completion of Mathematics 353 or 381 is strongly recommended for students without credits of Mathematics 267 or 277. Formally known as Mathematics 323.

A passing on the final exam – at least 50% - is required in order to earn a minimum grade of C- in this course.

Each piece of work (assignment, quizzes or final examination) submitted by the student will be assigned a percentage score. The student's average percentage score for the various components listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade [bearing in mind that grade of D+ or below will result if the student does not pass the final examination].
