Introduction to MINITAB
Assignment to be done in lab (not marked)

Objective: To become familiar with MINITAB:

- i) windows format – how to use the menus and dialog boxes
- ii) inputting data – how to input your own data
– how to retrieve particular files
- iii) finding descriptive statistics
- iv) some graphical routines

Click on **Start** in the lower left-hand corner of the screen. Click on **MathStats Packages** and then **Minitab 13 for Windows**. Finally, click on **Minitab**.

Spend a few moments finding your way around the MINITAB windows. Our main interest will be in the DATA window, which serves as the worksheet for entering data, and the MENU bar that allows the selection of commands to perform various tasks. Results are presented in the SESSION window.

Example 1: Entering data

The values below represent the grade point averages of 30 randomly selected U. of C. Students:

2.0 3.1 1.9 2.5 1.9 2.3 2.6 3.1 2.5 2.1
2.9 3.0 2.7 2.5 2.4 2.7 2.5 2.4 3.0 3.4
2.6 2.8 2.5 2.7 2.9 2.7 2.8 2.2 2.7 2.1

i) Enter this data into the first column, c1, of the worksheet in the DATA window. Note that it will be necessary to use the “down arrow” key after typing each value to move down the column.

Enter GPA in the blank cell under the c1. This assigns a name for the “variable” in that column.

Before proceeding, be sure that the highlighted cell is not one of your data values – click anywhere else on the worksheet.

ii) From the MENU BAR select GRAPH > HISTOGRAM... a dialog box appears.

Click the mouse on c1 GPA in the rectangle on the left of the box: then press SELECT. This enters the name of your variable as one to be graphed. {Or type c1 in the GRAPH VARIABLES cell.}

Move to the table headed DATA DISPLAY and click the arrow in the DISPLAY cell. Select BAR from the choices given. Be sure the FOR EACH column specifies GRAPH. Press OK and note the results.

Return to the HISTOGRAM dialog box and investigate the variations that are possible with the buttons and menus available in that box. Eg class width etc.

iii) Again, select GRAPH from the MENU BAR. Choose CHARACTER GRAPHS > STEM-AND-LEAF.

Highlight c1 GPA as before and press SELECT. Select INCREMENT and type 1. Then click on OK. Try different increments.

Have a look at the dotplot for this data by using CHARACTER GRAPHS > DOTPLOTS.
 (iv) To find the sum, mean, standard deviation etc. Click on Calc>Column Statistics.
 Click on Input variable: Click on C1. Click on any of the statistics (eg. Sum, mean) and then click on Okay. STAT>Basic Statistics> Display Descriptive Stats will also give you the mean, standard deviation etc.

Example 2: Using MINITAB files

Students in an introductory statistics course participated in a simple experiment. Each student recorded his or her height, weight, gender, smoking preference, usual activity level, and resting pulse. Then they each flipped a coin and those whose coin came up heads ran in place for one minute. The entire class then recorded their pulse rates again. The data is saved in a worksheet called PULSE.MTW

To retrieve the worksheet: Choose FILE>OPEN WORKSHEET ... a dialog box appears. Click on the icon Data. Type PULSE.MTW in the FILE NAME box – or – scroll through the files listed below it until you find the pulse file and click on it. Press OK. The results of this experiment appear in the worksheet in the DATA window.

Variable	Description	Variable	Description
C1 'PULSE1'	Resting pulse rate	C5 'SEX'	1=male 2=female
C2 'PULSE2'	Second pulse rate	C6 'HEIGHT'	Height in inches
C3 'RAN'	1= ran in place; 2=did not run in place	C7 'WEIGHT'	Weight in pounds
C4 'SMOKES'	1=smokes regularly 2=does not smoke regularly	C8 'ACTIVITY'	Usual level of physical activity; 1=slight; 2=moderate;3= a lot

- i) Compare the resting pulse rates of the students according to their level of activity by examining the three dotplots: GRAPH>CHARACTER>DOTPLOTS
 Select PULSE1 as the variable to be plotted {highlight and SELECT}
 Click the BY VARIABLE check box: click in the text box following it; double click on c8 ACTIVITY in the box listing the variables {or click and SELECT}
 Click OK and the dotplots are given one above the other.
 To compare the actual values: STAT>Basic Statistics> Display Descriptive Stats. Click the Variable Box , double click on PULSE1. Click the By Variable check box. Double click on Activity. Click on OK or hit enter. Compare the means, medians Standard deviations etc.
- ii) Compare the descriptive statistics of the resting pulse rate according to activity level in a similar fashion.
- iii) Draw boxplots of the resting pulse rate according to activity level:
 GRAPH>BOXPLOT. Designate PULSE1 as the Y (measurement) and ACTIVITY as the X (category). Click OK.

iv) Use MINITAB to help you answer the following question:

1. Compare the resting pulse rate of males and females by discussing the relative position of their central measures; the spread and shape of the respective distributions.
2. What is the range of resting pulse rate for those classified as regular smokers?
3. What is the difference in the mean 'second pulse' rate for those who ran in place and the mean of those who did not?

Example 3. Importing data from a disk/cd

Practice importing a file from a disk and plotting dotplots, boxplots and histograms. Also look at descriptive stats. If there are different groups in the data set, compare dotplots, boxplots, histograms and descriptive stats like the previous questions.

Additional Questions:

1. Suppose you randomly select 20 students from the class (Stat 213) and collect data for these 3 variables

X: # of courses enrolled in

Y: total cost of textbooks and supplies for courses enrolled in

Z: method of payment used to buy textbooks and supplies for courses enrolled in

- (a) Describe the population.
 - (b) Describe the sample.
 - (c) Classify the responses of the above variables as categorical or quantitative. If quantitative, identify as discrete or continuous, if categorical, identify as ordinal or not.
2. A consumer group has made a study of the amount of music on classical compact discs. The discs have a capacity of 70 minutes of music but many discs are released with much less. The results of their study of a sample of 318 classical discs are shown below:

Playing Time	Relative Frequency
0 and under 30	0.025
30 and under 35	0.186
35 and under 40	0.308
40 and under 45	0.211
45 and under 50	0.135
50 and under 55	0.094
55 and under 60	0.006
60 and under 65	0.025
65 and under 70	

- (a) Complete the table by filling in the missing relative frequency. (0.01)

- (b) Draw the first three classes of the relative frequency histogram for this data.
- (c) What **percentage** of the sample had playing times of at least 50 minutes? (13.5%)
- (d) **How many** CD's in the sample had playing times of at least 30 minutes but less than 60 minutes? 298.92

3. The following summary statistics were obtained from a data set with 1000 values:

$$\text{Mean} = 60.5 \quad \text{Median} = 64 \quad \text{Standard deviation} = 10.5 \quad Q_1 = 55.5 \quad Q_3 = 76.0$$

Indicate approximately **how many** observation are the interval from 55.5 to 76.0 (500)

4. The campus branch of the Royal Bank randomly selected a sample of student accounts and checked the corresponding balance (rounded to the nearest dollar amount). The resulting data follows :

458, 623, 449, 721, 441, 498, 609, 557, 587, 435, 567, 760, 505, 876, 535, 684

Find the following: mean, median, mode, Q1, Q3, standard deviation, and the interquartile range. ($\bar{x} = 581.5625$, median = 562, no mode, $Q_1 = 478$, $Q_3 = 653.5$, $s = 126.7217$, $IQR = 175.5$). Note Q_1 and Q_3 are calculated differently on the computer so they may not be the same as those calculated by hand. Please find Q_1 and Q_3 by hand.

More Questions

Do questions at the end of each section in the book and the supplementary exercises. Some of the data can be input from the disk/cd instead of inputting by hand. These are excellent review questions.
